If a substitute player is of higher ability than the player they are replacing, the results of those games will be referred to the match committee, UNLESS THE OPPOSING TEAM CAPTAIN AGREES TO THE SUBSTITUTE PLAYER PRIOR TO THE COMMENCEMENT OF THE MATCH.
